14.2.3 Nomenclature of Directorate of Distance Education.

As per the UGC-DEB regulations 2020, the nomenclature of Directorate of Distance Education (DDE) was to be redesignated as Centre for Distance and Online Education (CDOE). The UGC in their communication insisted on renaming the Directorate as Centre for Distance and Online Education. Accordingly, the University vide Notification No. MANUU/ER-I(B)/F.110/2024-25/538 dated 24th July, 2024 has renamed DDE as Centre for Distance and Online Education (CDOE).

The Committee ratified the same.

UGC-DEB invited fresh applications from eligible Higher Educational Institutions (HEIs) for recognition to offer programmes under Open and Distance Learning (ODL) mode from the academic year 2024-24 academic session beginning from July-August, 202 and onward vide UGC Public Notice F.No.1-16/2024 (DEB-I) dated 6th May, 2024.

Accordingly, DDE, MANUU has submitted the application to UGC-DEB portal for recognition of B.Ed. programmes on 29.05.2024. The Online Interface Expert Committee Meeting was held on 21st August, 2024. UGC-DEB has recognized B.Ed. ODL programme for the academic year 2024-25 vide email dated 8th October, 2024.

The Committee ratified the same.

14.2.5 Prospectus of UG/PG/Diploma/Certificate programmes for the Academic year 2024-25.

The Prospectus of UG (B.A., B.Com and B.Sc.) PG (M.A. Urdu, Hindi, Arabic, Islamic Studies, History and English), Diploma (Journalism and Mass Communication, Employability Skills, Teach English, Early Childhood Care and Education and School Leadership and Management) and Certificate (Functional English and Proficiency in Urdu through English) programmes is prepared for the academic year 2024-25.

The Committee approved the same.

14.3.2 Proposal to Create a Panel of Academic Counsellors at LSCs

It is proposed that a panel of Academic Counsellors with supporting documents may be prepared by RCs/SRCs, so that academic counselling may be conducted smoothly, and shortage of the counsellors may be avoided. The pool/panel of Academic Counsellors thus prepared may be approved and maintained at CDOE with supporting documents. No further documentary evidence should be made mandatory for the Academic Counsellors drawn from the pool/panel.

The Committee suggested that the proposed Panel of Academic Counsellors and the applications of the Academic Counsellors should be routed through the Principal/HoI of the College. The Committee approved the same.

Further, presently the Academic Counsellors at LSCs are being appointed year wise. To overcome procedural difficulties, it is proposed that the Orders of the Academic Counsellors be renewed every two years. The Orders for the Appointment of Academic Counsellor may be for a minimum of two-year period (extendable by every two years) subject



to availability of required minimum strength to conduct the counselling session from the academic session 2024-25 onwards.

The Committee approved the same.

14.3.3 Approval of PPR Diploma in 'Digital and Social Media' in Online Mode

This Diploma was initiated as "Public Relations (PR) & Advertising" in blended online mode and approved in 13th CIQA Meeting vide item no. 13.4.2. After several discussions of the expert committee, it was proposed to change the nomenclature of the programme as Diploma in Digital and Social Media. Accordingly, PPR has been prepared and placed before the committee.

The Committee approved the same. Further, the Committee suggested to tie up with the Institutions and Media Houses at all India level for training purposes for the students of Digital/Social Media.

14.3.4 Approval of PPR for Diploma in Urdu in ODL Mode

The PPR for Diploma in Urdu is placed for consideration.

The Committee approved the same and suggested that the syllabus should be the same for both the regular and distance mode students. The Diploma should be equivalent to 10th standard and shall be offered by CDOE for both regular and distance mode students in ODL/Online Mode.

14.3.5 Implementation of NEP 2020 in ODL Mode

Communication received from UGC-DEB dated 27th June, 2024 for implementation of 4 Year Bachelor's Degree Programmes based on NEP-2020 in ODL Mode.

The Committee noted and approved the same.

14.3.6 Structure for 4 YUG programme under NEP 2020 in ODL Mode

As per the synchronization of Structure and Syllabus under NEP -2020 4 Year UG (4YUG) programmes, CDOE held a series of separate meetings with the Deans of Schools and the Heads of the Departments (conventional mode) for the B.A., B.Sc., and B.Com programmes. The minutes of the meetings for B.A., B.Sc., and B.Com. are placed at (Annexure -5). After detailed discussions and deliberations, the following was resolved:

- 1. The Structure for 4YUG Dual-Major Programme (B.A., B.Sc., B.Com) shall be adopted by CDOE without any change to facilitate mobility and entry-exit options as provided under NEP-2020.
- 2. The Compulsory Courses: The Compulsory Courses offered under Discipline Specific Course (DSC) and Discipline Specific Elective (DSE) in the conventional mode for each Major discipline shall remain unchanged for B. Sc (Life Sciences & Physical Sciences), B. Com and B.A in Open and Distance Learning (ODL) mode. Accordingly, the SLM preparation work has been initiated
- 3. Skill Enhancement Courses (SEC): The SEC for B. Sc (Life Sciences & Physical Sciences), B. Com, B.A Arabic and B.A Hindi shall be adopted as approved in the regular Department and remain same as offered in conventional mode. It may please be noted that



the SEC for B.Sc at CDOE will not have any practical component. The SEC for B.A (other than Arabic and Hindi) shall be offered as follows:

9. Question Paper: The pattern of the question paper shall be the same as in the conventional mode.

10. Counselling:

- i. For B.A., B.Sc., and B.Com programmes, there shall be counseling-cum-contact classes for the Dual Major DSC and DSE courses; AEC; and GE courses in the blended mode: face-to-face at the LSCs subject to minimum required enrollment and the remedial online counseling shall through the DMMC, CDOE, MANUU and IMC, MANUU.
- ii. Counseling classes for SEC and VAC shall be conducted through the online mode ONLY through the DMMC, CDOE, MANUU and IMC, MANUU.

11. Evaluation:

The Committee suggested the nomenclature of point no. 6 (ii) may be Gender Studies in place of Understanding Gender; at point no. 6 (iii) may be Social Values in place of Human Values and Professional Ethics, and advised CDOE to have it corrected by the respective departments. The Committee also suggested on point no. (8) that Summer Internship may be in audio visual format also. The Committee further advised that Persian as a subject may be introduced at UG level.

The Committee approved the 4YUG Structure.

14.3.7 Approval of Self-Learning Material (SLM) for B.Ed. (ODL) Program

The Self-Learning Material (SLM) for all 4 semesters of the B.Ed. (ODL) program has been meticulously developed in alignment with the guidelines of the UGC-DEB. The SLM



is designed to cater to the academic and pedagogical needs of distance learners, providing high-quality content and activities to support self-paced learning. It includes comprehensive modules, assignments, and practical activities, covering all core, elective, and practical components of the program.

The SLM has been structured to meet UGC-DEB's quality benchmarks, ensuring compliance with regulatory standards. It will be made available in both printed and digital formats for the convenience and accessibility of learners. The CIQA's approval is sought to implement the developed revised SLM in the B.Ed. (ODL) program and proceed with its distribution to students.

The Committee approved the same.

14.3.8 Approval of CIQA Report for 2023-24

The Committee approved the CIQA Report for the year 2023-24 and the same is to be placed before the Academic Council for approval.

The Committee approved the same.

14.3.9 Proposal for Online Workshops for B.Ed. ODL Students

B.Ed. (ODL) students are required to attend four 3-day workshops, one in each semester, as part of their program. While offline workshops are provided free of cost, some students are unable to participate due to personal or official reasons. To address this issue, it is proposed to offer an online workshop option as an alternative for such students. Each online workshop will be conducted over 3 days and will incur a fee of ₹1,200/-, amounting to a total of ₹5,000/- for all four workshops.

These online sessions will be conducted on platforms like Zoom or Google Meet and will maintain the same objectives and outcomes as the offline workshops. The online workshops will be scheduled and completed before the final semester examinations to ensure students meet the program requirements. This initiative aims to provide flexibility and inclusivity while upholding the academic integrity of the program.

The Committee advised the workshop be conducted in proctored manner and approved the same.

14.4 Any Other Item with the Permission of the Chair.

Hon'ble Vice-Chancellor advised the following points:

- 1. To resolve the grievances of the CDOE students including B.Ed. (ODL) by calling them at Headquarters by providing accommodation at Ismat Girls Hostel for Women/Girls students and for Male students accommodation may be provided at any suitable hostels in coordination with Provost (Boys Hostel). Dr. Jamaluddin Khan has suggested that there should be a help desk of CDOE for instant student support services. The suggestion was accepted and the Chairman of the Committee advised to implement the same by starting a dedicated Help Desk at CDOE and assured that the requirement of manpower shall be met for this purpose.
- 2. A 6-member Coordination Committee of CDOE and IMC shall be constituted with the following members: Director, CDOE (Chairperson), Director (IMC), two



members each from CDOE and IMC for effective academic activities of ODL and other programmes.

- 3. The requirement of technical staff for Digital Multimedia Centre of CDOE shall be filled-in at the earliest, with full Coordination with IMC.
- 4. The third floor of the building where MANUU Law School is housed shall be allotted to CDOE after getting it fully furnished for the purpose of Faculty Cabins/Counselling/Workshop/Administration/Examination/Evaluation/SLM storage etc.
- 5. To cover the activities of CDOE, regularly a news item shall be included in weekly News Bulletins of IMC.
- 6. Prof. V Venkaiah advised that the CDOE may also take the help of Open Educational Resources (OER) for various programmes offered by the CDOE, as there would not be any issue of copy right material. The material is available in English that can be translated into Urdu.
- 7. The Committee placed on record the services rendered by Prof. Mohd Razaullah Khan, Director, CDOE and expressed deep appreciation of his contribution. Endorses efforts made by Prof. Gulfishaan Habeeb for smooth sailing in the absence of Prof. Mohd Razaullah Khan.
