57. Item for Consideration

57.4(1) Confirmation of Minutes of 24th Academic Council meeting held on 28.03.2016

The Registrar presented the minutes of 24th Academic Council meeting held on 28th March, 2016 for confirmation of the Executive Council. The EC noted and confirmed the Minutes of 24th Academic Council held on 28.3.2016.

57.4(2) To consider promotion of Teaching staff covered under CAS as per provisions of UGC Regulations-2000

The Registrar informed that the University has received representations from the teaching staff members who were eligible before 31.12.2008 for promotion as per UGC-Regulaions-2000 under Career Advancement Scheme. Since the University has not adopted the UGC Regulations-2000 on Minimum Qualifications for Appointment and Career Advancement of Lecturers, Readers and Professors in the Universities and Colleges, as such few cases of teachers who are eligible for promotion under CAS in terms of Regualtions-2000 are under consideration.

However, the University with the approval of the Executive Council at its 35th meeting held on 12.11.2010 has already adopted the UGC-Regulations-2010 on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Measure for the Maintenance of Standards in Higher Education. The promotion of such candidates who became eligible for promotion under CAS in terms of UGC Regulations-2010 on or after 31.12.2008 has been considered by the University.

The Vice-Chancellor informed the Executive Council that the UGC Regulations 2000 are required to be adopted to consider the cases of promotion of eligible teachers under these regulations.

The EC agreed to the above and adopted UGC Regualtions-2000 for promotion of teachers who were eligible before 31.12.2008 under CAS in terms of the UGC Regualtions-2000.

57.4(3) Change of designation from Physical Education Teacher to TGT-Physical Education in respect of Model School Teachers

The Registrar informed that the UGC has sanctioned 07 Physical Education Teacher posts to MANUU Model Schools (Darbahnga, Nuh and Hyderabad). The University has already appointed 05 Physical Education Teachers and remaining 02 posts are lying vacant. The vacant posts have been notified vide Employment Notification No. 36/2015.

The CBSE vide letter dated 10.02.2013 has amended / additions in affiliation byelaws of the Board have been made. At S. No. 4 of the amended rule, it is stipulated that "In additions to 10.1 (i), (ii) & (iii) "Every school should appoint Physical Education Teacher in the prescribed grade with people ratio 1:500 at each stage i.e. Primary Level, Secondary level and Sr. Secondary level and they should be redesignated as PRT-Physical Education, TGT-Physical Education and PGT-Physical Education"

The following teachers who were appointed as Physical Education Teachers in MANUU Model School have represented to change the designation from Physical Education Teachers to TGT-Physical Education as per CBSE Bye-Laws.

The Executive Council approved the change of designation from Physical Education Teacher to TGT-Physical Education of the above mentioned Model School teachers.

57.4(4) To consider request of Model School Teachers for acceptance of B.Ed qualifications

The Registrar informed the EC that we have been receiving many cases where staff are pursuing various courses without obtaining prior permission from the Competent Authority. It was decided to place such cases before the Executive Council for consideration. Therefore, the matters were placed before the Executive Council at its 52nd meeting held on 25.04.2015 and EC passed resolution to consider all such non-permission cases of pursuing higher education by the employees on case to case basis.

The Registrar informed that placing all such cases every time before the EC is waste of precious time of the EC. Instead the University may issue a Circular with strict instructions that prior approval shall be obtained before pursuing courses.

The Executive Council approved the present cases of Ms. Kausar Salma, Ms. Azra Rasheed and Mr. Nisar Ahmed Peerzade and decided not to consider such cases in future and also directed to issue a Circular in this regard. The Head of Dept. / Section Head should also be asked to enlighten the staff for obtaining the permission so that rules on Employees code of Conduct of Central Governments are not violated.

57.4(5) Discontinuation of interview at Junior Level Posts in Govt. of India

The Registrar informed that as per recommendations of Committee of Secretaries, the Ministry of Human Resource Development vide DoPT's O.M. No. 39020/01/2013-Estt.(B)-Part dated 29.12.2015 requested to submit the status report on the progress of implementation of "Discontinuation of Interview at Junior Level Posts". The UGC vide letter dated 14.01.2016 directed the University for strict compliance of the recommendation of the Committee of Secretaries. The timelines set regarding completing the process of the discontinuation of interview by 31.12.2015 has to be



adhered to strictly. From 1st January 2016 there will be no recruitment with interview at the Junior level posts.

The University issued an Employment Notification No. 35/2015 dated 31.3.2015 for filling up of various Non-Teaching position. The interviews of Group-B, C & D are to be held. The Selection process of various Non-Teaching posts is still underway.

In view of the Govt. of India Orders interviews for Junior level posts (Non-Gazetted Group-B and equivalent cadre, Group-C & D) is to be discontinued. The posts already notified by the University for various Non-Teaching Positions through Notification No. 35/2015 is to be re-notified and hereafter there shall not be interview for the Junior Level Posts.

The Executive Council considered the matter and approved to implement the instructions of Govt. of India.

57.4(6) Abstract of the Finance Committee meeting to be held on 20.06.2016

The Abstracts of the minutes of the Finance Committee held on 20.06.2016 was placed before the Executive Council at its meeting held on 21st June, 2016. The Executive Council approved Annual Accounts of the University for the year 2015-16 as recommended by the Finance Committee.

57.5 Any other item with the permission of the Chair.

57.5(1) Release of Terminal benefits on the removal of Dr. Mohd. Shujath Ali, Deputy Director, CPDUMT

The Registrar informed the EC that in pursuance of the decision taken by the Executive Council at its 56th meeting held on 7.3.2016, Dr. Mohd. Shujath Ali, Deputy Director (under suspension), CPDUMT was removed from the services of MANUU w.e.f 21.03.2016 in a disciplinary case.

Entitlement of Compassionate Allowance under CCS (CCA) Rules:

If the case of the Govt. Servant who is removed or dismissed from service deserves special consideration, the authority competent to remove or dismiss him from service may sanction a Compassionate Allowance not exceeding two-thirds (2/3rd) of pension or gratuity or both which would have been admissible to him if he had retired on compensation pension. The Compassionate Allowance shall not be less than Rs. 3500/- per month. Dearness relief is also admissible on the Compassionate Allowances – Rule 41 CCS (Pension) Rules. The Compassionate Allowance is also a kind of pension and commutation is admissible (Rule 3 (1) (j), CCS (Commutation of Pension Rules).

The payment of terminal benefits on removal from the services is to be considered by the Executive Council taking into consideration the case of Govt. Servant who is removed or dismissed from service deserves special consideration, the Authority Competent to remove or dismiss him from service may sanction a Compassionate Allowance not exceeding two-thirds (2/3^{rd)} of pension or gratuity or both which would have been admissible to him if he had retired on compensation pension, may be considered by the Executive Council.

The Executive Council after discussion considered the matter of sanction of terminal benefits as special consideration and approved to release both pension and gratuity to Dr. Mohd. Shuajth Ali.

57.5(2) Release of Terminal benefits to Mr. Shaik Mohammed, Office Attendant on imposition of major penalty retired (Compulsory) from the services of MANUU

The Registrar informed the EC that in pursuance of the decision taken by the Executive Council at its 50th meeting held on 10.01.2015, Mr. Shaik Mohammed, Office Attendant (under suspension) on imposition of major penalty in a disciplinary case was Retired (Compulsory) from the services of MANUU w.e.f 04.03.2015.

As per rule 40 of CCS (Pension) Rules, 1972, a Govt. servant compulsorily retired from service as a penalty may be granted pension or gratuity or both at the rate not less than two-thirds $(2/3^{rd})$ and not more than full compensation pension or gratuity or both admissible to him on the date of his compulsory retirement.

Further, it was enunciated in the GID (1) below Rule 40, the intention is that persons on whom penalty of compulsory retirement is imposed should ordinarily be granted the **full compensation pension and retirement gratuity**. However, the circumstances of a particular case so warrant, the Competent Authority may make such reductions in the pensionary benefits, within the limits prescribed as it may think appropriate.

The payment of terminal benefits on compulsory retirement from the services is to be considered by the Executive Council as per Govt. of India rules by taking into consideration the case of the Govt. Servant who is retired (compulsory) from service may sanction pension or gratuity or both will not be less than two-thirds (2/3rd) and not more than full compensation pension or gratuity or both admissible on the date of compulsory retirement.

The Executive Council after discussion considered the matter of sanction of terminal benefits as special consideration and approved to release both pension and gratuity to Mr. Shaik Moahmmed.

57.5(3) Expenditure on payment of salaries to Drivers from Plan budget against the posts created with approval of the Executive Council

The Registrar informed that there were seven (7) posts of Drivers in the University against the requirement of twelve (12) Drivers. Keeping in view of the requirement, a proposal of Five (5) more post of Drivers was placed before the 47th meeting of Executive Council held on 12th February, 2014. The Executive Council approved the creation of five (5) posts of Drivers in the University in accordance with Section 13 (2) (iii) of Act & Statutes of the University.

Accordingly, the University filled up the four positions of the Drivers out of five on the recommendations of Selection Committee. The matter of appointment of four Drivers was ratified by the Executive Council at its 51st meeting held on 28th February, 2015. The expenditure on salaries of Drivers was met from Plan Grants during the financial year 2015-16.

The Executive Council resolved to approve the continuation of payment of salaries to Drivers from the Plan Grants.
