NOTIFICATION

The Executive Council in its 72nd Meeting held on 27th December, 2018 considered the report of the Committee dated 1.10.2018 constituted by the University to review of the functioning of various constituent institutions and Centres under MANUU with reference to the objectives and mandate of the University in terms of UGC communications No. F.48-3/2017(CU) dated October, 2017 and letter No. F.No.48-1/2017(CU), dated 12th March, 2018. The following were the brief observations and recommendations of the Committee with reference to re-organization of Centers established by the University:-

- (i) As per the University Act, Statutes (Section 2(f) and Statute 16 related to Schools of Studies and Departments), the University shall have Schools of Studies. Each School shall consist of such Departments as may be assigned to it by the Ordinances. Provided that the EC may, on the recommendations of the AC, establish Centres for Studies to which may be assigned such teachers of the University as the EC may consider necessary.
- (ii) The Academic Council in its 16th Meeting held on 3rd Feb, 2011 had resolved to constitute Advisory Committee for each Centre of the University with the Vice-Chancellor as Chairperson with the Director as its Member Secretary with other faculty members and external members. The tenure of such Advisory Committee constituted by the University shall be for a period of three years. At present, these Centres are not linked to the other Departments and Schools for teaching-learning and research activities.
- (iii) In view of the above provisions and to provide linkage with other Schools and Departments within the statutory framework of the University for optimum utilization of potentials of the Centres and to encourage to take up inter-disciplinary teaching and research work, the Committee had recommended that the following five existing Centres which are funded by the University Grants Commission (UGC) may be made as part of the School of Studies:-

- (iv) The Committee further recommended that the existing arrangements of Advisory Committee to the aforesaid Centres as approved by the Academic Council/Executive Council may be continued with suitable modification in its constitution/composition.
- 2. The Executive Council took note of the UGC communications No. F.48-3/2017(CU) dated October, 2017 and letter No. F.No.48-1/2017(CU), dated 12th March, 2018. According to the observations of the UGC that there are a large number of constituent units/Centres/Campuses under the umbrella of MANUU and the number of students enrolled in these entities are not at the desired level due to which, the utilization of infrastructure is not being fully utilized. Therefore, the University should review the functioning of these Units for its further continuance in case the sufficient students are not available. The UGC also sought an Action Taken Report (ATR) in this regard. The EC, therefore, felt that these Centres located at MANUU Main Campus, its teaching staff and its infrastructure should be fully utilized for teaching-learning-research activities to meet its objectives for which they have been established by the University.
- 3. The Executive Council keeping in view of the UGC directives and after taking into considering the recommendations of the Review Committee *resolved* to accept the above recommendations of the Committee as recommended by the Academic Council in its 32nd Meeting held on 04.10.2018.
- 4. Accordingly, the five existing Centres namely (i) Centre for Women Studies; (ii) Al-Beruni Centre for the Study of Social Exclusion and Inclusive Policy; (iii) H.K. Sherwani Centre for Deccan Studies; (iv) Centre for Professional Development of Urdu Medium Teacher and; (v) Centre for Urdu Culture Studies are hereby made as part of the School of Studies as detailed at para 1(iii) above with effect from 1st January, 2019.
- 5. Henceforth, any proposal and policy matter which requires the approval of the Academic Council such as research proposals, introduction of new courses, designing of curriculum/syllabus, academic collaboration with other Universities/Research Institutions etc. arising out of the recommendations of the Advisory Committees/Research Committees of the Centres shall be submitted through the respective School of the Studies to which the Centre is attached.
- 6. The Dean of the respective School concerned being the Head of the School shall coordinate and supervise the teaching and research work of the Centre concerned through its Director in terms of Clause 2(a) of the Ordinance related to the Functions of the Deans of Schools of Studies, published in the Official Gazette dated 21st November, 2006.
